VII. Committee Reports

A. Community Relations Committee

1. Racial Profiling Meeting with Josephine Jackson, Duval County Schools

Commissioner Casey Bulgin reported that Josephine Jackson, Director, Office of Equity and Inclusion for the Duval County School Board, was the guest speaker. The committee discussed policies and practices being implemented in the Jacksonville schools around bullying and racial profiling.

2. Human Trafficking

Commissioner Freed stated a Human Trafficking Program will be held during January 2014, which is Human Trafficking Month. The vision is to raise community awareness by using art as the medium. The proposed exhibit will be moved to multiple locations around the city. In addition, E. Benjamin Skinner, author of "A Crime so Monstrous" will be speaking on January 11th, Human Trafficking Day. This program would also tie into the Art Walk that will be held on February 5, 2014, (the Art Walk is held the first Wednesday of the month).

VIII. Executive Director & Staff Reports

JaxScore is a new screen that will appear on the COJ website. JaxScore will show performance measurements for each department. The JHRC's measurement will be reported on a quarterly basis.

Afvрилл Thompson, who volunteered with the JHRC for three years, will join the JHRC as a full-time (paid) staff member.

A "cause" decision was issued on a housing complaint based on familial status. The amount awarded to the client was \$27,500. (Familial status covers families with children under the age of 18.)

Communications are continuing with the EEOC Miami Regional Director, Malcolm Medley, regarding the expansion of the JHRC's jurisdiction to include surrounding counties. (This was a suggestion made by City Council President William Gulliford during the FY14 budget meeting.)

Bill Randall, from Clay County, called to ask how to set up a Commission like the JHRC in Clay County. He asked if it was possible for the JHRC to provide services for Clay County. He will submit a proposal to Clay County City Council.

The City Council of Atlantic Beach is introducing a change to its ordinance to include sexual orientation and gender identity and expression. This meeting will take place on November 25, 2013 at 6:30 p.m.
