



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5902-24C was filed on April 17, 2024, as Ordinance 2024-306.

The subject site is approximately 2.10 acres and is located with an address of 226 Jackson Road, between Lee Road and Interstate-295.

The current land use category is Medium Density Residential (MDR). The proposed land use category is Residential Professional Institutional (RPI). Plan category descriptions can be found on the Planning and Development Department website.
