

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5916-24C</u> was filed on <u>April 3, 2024</u>, as <u>Ordinance 2024-277</u>.

The subject site is approximately <u>0.87 acres</u> and is located with an address of <u>618 Stockton Street</u>, between I-10 and Rosselle Street.
