- 1. Call to Order/Verify Quorum: Chair Shirley Lowry called the meeting to order at 6:40 p.m. Michelle Godwin verified a guorum.
- 2. Approval of the Previous Meeting Summary: Tom Martin moved that the March meeting summary be approved. Len Burroughs seconded the motion. The motion passed unanimously.
- 3. Elected Officials' Reports:
- City Council Member, District 10, Terrance Freeman, introduced himself to CPAC members and was available for questions.

#### 4 Presentations

- Gloria McNair, Community Engagement Specialist Outreach Groundwork Jacksonville, presented on the plans for the Emerald Trail project. Ms. McNair explained how Groundwork is engaging neighborhood stakeholders, business leaders, contributors and the City to plan and build the Emerald Trail within the next 10 years. When complete, the trail will comprise of approximately 19.7 miles of new trails, greenways and parks that encompass the urban core and link at least 14 historic neighborhoods to downtown, Hogans Creek, McCoys Creek, the S-Line Rail Trail and the Northbank and Southbank Riverwalk. Ms. McNair explained the trail will link to 18 schools, two colleges and 28 parks, as well as other destinations like restaurants, retail and businesses. The Emerald Necklace has the potential to spur social and economic development in Jacksonville. The Trail's Master Plan is broken into three implementation tiers. In the area of Manotak Avenue and Lane Avenue, suspects are entering homes through back doors and windows. Guns have been taken from a few of the homes. Two of the suspects have been caught. Lt. Eason reminded CPAC members to use the 9 p.m. route as a reminder to bring your guns in from your car, and to lock your car doors as well as your house doors.

- Municipal Code Compliance Division (MCCD) Bruce Chauncey, Zone 4 Compliance Supervisor, announced that the Municipal Code Compliance Division will be releasing a newsletter each month with helpful tips and information, as well as the MCCD inspection stats for the month. Mr. Chauncey introduced Robert Bautochka, the new senior officer for Zone 4. Mr. Chauncey reported that 1,516 inspections were completed in Zone 4 between March 12 and April 8, 2019. These included 42 illegal signs, 89 litter signs, 232 junk vehicle inspections, 641 nuisance inspections, 28 nuisance board ups, 213 residential inspections, 35 inspections of unsafe structures, 175 zoning, and 14 commercial inspections. The Municipal Code Compliance Division completed 10,381 inspections throughout Jacksonville. Mr. Chauncey also announced that the Municipal Code Compliance Division is hiring.   - **2018-0608 PUD Rezoning** South side of 103<sup>rd</sup> Street, west of Connie Jean Road: PUD rezoning seeks to permit school bus storage expansion.
  - **2018-0830 Conventional Rezoning** 9101 McClelland Rd.: Request to rezone property south of Normandy Boulevard. from PUD-SC to Agriculture zoning district.
  - **2019-0186 Conventional Rezoning** 1367 Chaffee Rd.: Request to rezone from PUD to RLD-80 for single-family development.
  - 2019-0194 Planned Unit Development Rezoning 4851 Collins Rd.: Rezoning from RMD-A, IBP and PUD 2006-281 to PUD 2006-281 to PUD. The rezoning to PUD is for multi-family, like the previous PUD, but includes three new parcels and increases the maximum density.

# 6. Subcommittee/Liaison Reports:

- Cecil Area Bruce Tyson reported that a bus tour of Cecil Field is scheduled for May 9, 2019. The ticket price is \$20 and the tour will begin at 8 a.m. Registration deadline is May 6, 2019. Mr. Tyson reported that the construction of the new fire station is moving forward, and an open house is planned sometime in May or June. The rocket launch testing pad is in place and the first text launch is scheduled for some time in September or December.
- Transportation Tom Martin reported for the April 3, 2019 North Florida TPO CAC meeting:
  - North Florida TPO CAC received a update presentation on the Smart Regions by Jeff Sheffield, TPO Executive Director. There were a number of questions concerning the Hart/Talleyrand Expressway project. The available documentation on design of the U2C Program, the Bay Street Innovation Corridor, and the Hart/Talleyrand Expressway seem to conflict, however Mr. Sheffield said there was no conflict. At the FDOT public meeting on March 14, 2019, the majority of those present opposed the project. Mt. Sheffield pointed out a design issue with the portion of Bay Street that is now one-way.
  - North Florida TPO CAC approved the FDOT request to amend the FY 2018/19 through FY 2022/23
    Transportation Improvement Program (TIP) for funding 26 miscellaneous projects in Clay, Duval,
    Nassau and St. Johns counties. Most of the projects are for engineering work or railroad crossing
    upgrades. Also included is funding for Urban Core Riverfront Revitalization and the Complete
    Streets Miscellaneous Construction project (Hart Bridge).
  - North Florida TPO CAC approved the JTA request to amend the FY 2018/19 through FY 2022/23
    Transportation Improvement Program (TIP) and the FY 2018/19 through FY 2019/20 Unified Planning
    Work Program (UPWP) for a Transit Oriented Development Pilot Grant. This planning grant is to look
    at the potential development and transit ridership in a half mile radius around each planned U2C
    stops in the area from Forest Street to Talleyrand Avenue and from 8th Street to San Marco.
  - North Florida TPO CAC approved the staff request to amend the FY 2018/19 through 2019/20
     Unified Planning Work Program (UPWP) for an increase in available funds.
  - North Florida TPO CAC received a short list of suggested studies for inclusion in the FY 2019/20
     Unified Planning Work Program (UPWP). The approval of the FY 2019/20 Unified Planning Work
     Program (UPWP) is scheduled for the May meeting.
  - North Florida TPO CAC received the draft project sections of the FY 2019/20 through FY 2023/24 Transportation Improvement Program (TIP)
  - North Florida TPO CAC received a presentation on the annual assessment for each county and each transportation authority.
  - North Florida TPO CAC received a presentation on the Path Forward Survey by Wiley Page of Atkins.
  - North Florida TPO CAC received an update presentation on the Transit Development Plan by Suraya Teeple (JTA) and Jeanette Berk of the consulting firm Gannett Fleming, Inc.
