### 3. Presentation from Disability Services:

A) Jose Morales, Chair of Mayor's Disability Council and Kara Tucker, Chief ADA Coordinator:

- Mr. Morales stated that CIL Jacksonville is a nonprofit organization with 12 Centers throughout Florida and is connected to some 300 centers in the U.S.
- 51% of the Jacksonville Staff and board have disabilities.
- The CIL Mission is "to empower people with disabilities to live independently.
- Core Services are: Advocacy, Peer Mentoring and Support, Transition, Independent Living Skills, and Providing Information and Referrals.
- CIL Jacksonville does not duplicate services already provided but complements the spirit of the ADA (Americans with Disabilities Act).
- CIL Jacksonville has a temporary loan closet of durable medical equipment for free, for short and long term basis
  - Items are donated by the community
  - CIL will make necessary repairs
  - 260 consumers serviced and over 1,200 pieces of donated equipment in 2022
- The Spirit of the ADA Event invites members from the disability community to a free day at the Jacksonville Zoo. This is a partnership between CIL and the City of Jacksonville's Disabled Services Division.
  - $\circ$   $\;$  This event helps to create awareness of people with disabilities
  - Gets people out of seclusion and allows them to interact with the rest of the community
  - Due to budget cuts this year's event was held at James Weldon Johnson Park
  - o Cost \$25,000
- Mr. Morales was invited to prepare a request for funding event proposal to the Subcommittee Chairs, inclusive of a brief write-up of what this ask is important to the overall community. The Mayor will view this as a priority.

- CIL Jacksonville also holds an Emergency Preparedness Conference
  - Provides an avenue to agencies to offer services to the disabled.
  - Looking to develop a component for youth
  - $\circ$   $\;$  Looking to expand the number of Conferences from 1 to 6  $\;$
- Mr. Morales was also invited to submit a event funding proposal inclusive of a one-page description of WHY this type of conference is needed, WHO benefits, WHAT's the purpose of this event, and HOW it is to be carried out and WHAT are the likely budget impacts of the event.

The Mayor's Disability Council meets the 1<sup>st</sup> Tuesday each month from 3:00 pm to 5:00 pm, in the mayor's Conference Room, 4<sup>th</sup> Floor of City Hall <u>COJ.net - Mayor's Disability Council</u>

B) Cara Tucker, Chief ADA Coordinator, City of Jacksonville ADA Compliance & Disabled Services Division: <u>COJ.net - Disabled Services</u>

- The overall goal of the Disabled Services Division is to improve the quality of life for people with disabilities by addressing, researching and attempting to resolve the many barriers they encounter.
- Barriers include transportation, housing, accessibility, discrimination and employment
  - The Division is responsible for:
  - Increasing awareness of the needs of people with disabilities
  - Monitoring federal and state legislation relating to disability rights and issues and advising the Mayor and her staff about necessary City compliance
  - Suggesting and implementing ordinances aimed at improving equal access and opportunity
  - Serving as staff for the Mayor's Disability Council
  - o Administering the Jim Brady Scholarship Fund Program
  - Partners with other non-profit organizations to provide programs/activities
    - Looking for a larger facility to hold various activities:
      - Senior Expo
      - Disability Expo
      - Sponsor Nights with Sports Teams
      - Currently in talks with Regency about space
- Ms. Tucker was invited to submit a funding proposal

- a. Non-Profit and Higher Education Revitalization Christian Harden and Angela Mann Reported by Georgette Dumont
  - Subcommittee reviewed City of Jacksonville's budget allocations to non-profit agencies. Kids Hope Alliance has received the most funding
  - Subcommittee is continuing with Higher Education interviews
  - Meeting in two-weeks to examine the various classifications of agency types
  - Will be sending in their recommendations to the full committee

    - Rodney Hurst will host the 63<sup>rd</sup> commemoration of Ax Handle Saturday on Sunday, August 27, 2023 at 4:30 pm at the Jessie duPont Center, 40 E. Adams St, (Corner of Ocean) – per Kiaira Nixon.
    - Additionally, Ms. Nixon understands that Mayor Deegan will be in attendance. The Chair will try to secure a Proclamation for the Mayor to read at the event.
    - Per Mr. Hurst there is a <u>1960 Civil Rights Demonstration Historic Marker (Axe</u> <u>Handle Saturday) - Clio (theclio.com)</u> located in James Weldon Johnson Park
    - Ms. Nixon will contact City Hall to get information on how to reserve exhibit space in the atrium the Chair will forward the link to the on-line application.
