#### A. Community Relations Committee

## 1. Human Trafficking Art Exhibit

Commissioner Crystal Freed provided an update on the Human Trafficking Program scheduled during January and February, 2014. The vision is to raise community awareness by using art as the medium. The art instillation will open on January 23, 2014 and will be moved to multiple locations around the city. The art panels will be on exhibit at the February 5, 2014 Art Walk at Hemming Plaza (the Art Walk is held the first Wednesday of the month). A victim of Human Trafficking will be keynote speaker on February 13, 2014 at Jacksonville University. In addition, E. Benjamin Skinner, author of "A Crime so Monstrous," will be speaking on February 23, 2014 at UNF. Additional information will be forthcoming.

A public service announcement (PSA) is in the process of being developed.

#### B. Employment Committee

The committee is looking into employment trends and what issue it wants to explore. Two issues discussed were mental health and disclosing a disability to an employer. The committee's goals and objectives will be determined at the next meeting.

#### VIII. Executive Director & Staff Report

Charlene Taylor Hill reported that she has been invited to be the keynote speaker at the Martin Luther King breakfast on Monday, January 20, 2014 in Clay County

Ms. Hill will email the Commissioners information on two events. The first is "Reclaiming Young Black Males for Jacksonville's Future." This program is being held the first Saturday in February. The keynote speaker will address keeping young black male students in school in order to reach their potential.

The second event is about the Ritz Chamber Players Concert to be held on January 22, 201.

Three Commissioners have resigned. Michele Rollins resigned to be able to volunteer with the JHRC. She has already conducted mediation and is also working on intakes. Sherry Murray resigned due to health reasons. Susan Harthill resigned to take a position with the United States Department of Labor as Deputy Solicitor and is relocating to Washington, DC. Tina Comstock has ended her second term and has decided not to serve until she is replaced.

Ms. Hill stated the staff has been encountering more mental health issues amongst people coming into the JHRC office. Employers are also having a difficult time with accommodating employees with mental health conditions. Commissioner Mario E. Decunto has agreed to meet with the JHRC staff to discuss the best ways to communicate with persons who may have mental health conditions. Ms. Hill also mentioned that JCCI will be conducting a study on the lack of funding for mental health and what is needed in Jacksonville to help remove the barrier or stigmatisms.

Ms. Hill reviewed the metric statistics for the month of December.
