- 1. Call to Order/Verify Quorum: Chair Green called the meeting to order at 5:30 p.m. Michelle Godwin-Ware verified a quorum.
- **2. Approval of the Previous Meeting Summary:** The August 12, 2022, summary was approved by the CPAC.
- 3. Elected Officials' Reports: None
- 4. Jacksonville Sheriff Office (JSO) Assistant Chief Lolita Smith reported:
 - JSO is short-staffed and needs dispatchers. The shortage has resulted in longer wait times for nonemergency calls because 911 calls take priority.
 - Crash fatalities are down by 36.
 - JSO is working with the Crime Analysis Department to stay ahead of street racing that has been taking place throughout Jacksonville.
 - Citizens should remove their weapons from their vehicles and lock their cars to reduce the number of firearms being stolen and used for murders.
 - October 5, 2022, is National Coffee with a Cop (CWAC). This day encourages communication
 and positive interaction between law enforcement and the public. This year's CWAC will take
 place from 9 a.m. to 11 a.m. at the Chick-Fil-A located in the River City Marketplace, 14020 Lunar
 Dr. Free coffee will be provided.

- 5. Jacksonville Fire and Rescue Department (JFRD) Capt. Byron Jackson reported:
 - Florida is at the height of hurricane season. Citizens can download the Jax Ready App to stay informed about evacuation zones, shelter locations, and much more. Citizens may register for AlertJax Notifications by visiting https://www.jaxready.com/Alerts.aspx.
 - Knox Box samples were made available to view. Homeowners may purchase a Knox Box for their homes to eliminate barriers and allow Firefighters to quickly gain access to secured properties in

- an emergency without causing property damage. For more information on how to purchase a Knox Box, visit www.knoxbox.com.
- Capt. Jackson reminded CPAC members that JFRD provides and installs free smoke detectors for any qualifying Jacksonville resident who owns and lives in a single-family or two-family residence.

- Fire Prevention week begins October 9, 2022, and will run through October 15, 2022. JFRD will be conducting public education and outreach regarding home fire safety. - **6. Chair's Report:** Chair Green selected CPAC members Joseph Tate, Sharon Bivins, and Larry Henderson to serve as members of the 2022 nominating subcommittee. Joseph Tate was chosen as the Chair of the nominating subcommittee.
- 7. **Presentation:** Tim Robertson, Director of Operations Eagle LNG Partner LLC, gave a presentation on Eagle LNG's planned 200-acre export facility and terminal located at 1632 Zoo Parkway along the St. Johns River. The new liquefied natural gas facility will produce approximately 1.65 million gallons of liquefied natural gas (LNG) daily and store 12 million gallons with truck and marine loading capabilities.

- Jacksonville Electric Authority (JEA) Donald Tuten, Governmental Relations, reported:
 - JEA provides free energy efficiency assessments for homes. A technician will show residents how

 - JEA will resume disconnections for non-payment beginning September 19, 2022. Customers at risk
 for disconnection will receive a two-day notice by email, phone, or text before power is cut off.

 assistance site at https://www.jea.com/assistance/
 - Starting October 1, 2022, JEA will no longer charge a credit card fee when paying your utility bill by credit card.

- Jacksonville Public Library (JPL) Jackie Spiritas, Executive Assistant I, reported:

- Municipal Code Compliance Department (MCCD) Allan Funez, Senior Code Compliance Officer, reported that 2,144 inspections were completed in August. Mr. Funez announced that the Jacksonville Assistance and Relief (JAR) Program now covers dead trees. A homeowner's case must be closed,

and the lien must be six months old. To qualify for the JAR Program, you must own and reside in a home within the City of Jacksonville, meet financial requirements, and have not used the JAR Program in the last year. - Election Signs at Highlands Regional Library have been removed.
- The property at 1205 Dunn Ave. was cited for the large hole in the ground.
- The overgrowth issue at the bus stop at 1164 Bacall Rd. has been forwarded to Mowing and Landscaping: Right-of-Way under reference number 220801-000620.
- 203 Rio Rd. has been cited for trash and debris. There is no evidence observed from the right-ofway that the vehicle on the property is abandoned or inoperable.

- Governmental Affairs and Planning & Development Jamie Lacy, Governmental Affairs Chair, and Erin Abney, City Planner II, reported that the Governmental Affairs Subcommittee reviewed 11 Land Use and Zoning applications with the CPAC, and four recommendations were made.

New Business

- Opposed 2022-0637-Conventional Rezoning: 0 Gillespie Avenue (RE:107684-0000): This application seeks to rezone approximately 1.44+/- acres from Residential Low Density 60 (RLD-60) to Commercial Residential Office (CRO) to be consistent with the surrounding properties.
- Opposed 2022-0670 Conventional Rezoning: 15311 Main St. North: This application seeks to rezone approximately 11.38+/- acres from PUD/CCG-2/RLD-100A to Residential Medium Density M (RMD-D) to develop the property with multi-family dwellings with a maximum density of 20 units per acre. (This is a companion to Administrative Deviation Ordinance #2022-0671).
- Opposed 2022-0671 Administrative Deviation:15311 Main St. North: This application seeks to reduce the minimum number of loading spaces from five required spaces to zero spaces. (This is a companion to Conventional Rezoning Ordinance #2022-0670).
- Opposed Z-4420 Planned Unit Development: 14353 Main St. North: This application seeks to rezone approximately 11.64+/- acres from PUD to PUD to develop the property with a maximum of 349 multi-family dwelling units, including future 10,000 square feet of commercial space and existing commercial properties.

All motions to approve the Governmental Affairs Subcommittee recommendations were seconded and approved by the CPAC members.
